RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

2. The Undersigned knowingly, voluntarily and for adequate consideration releases and waives, and further agrees to indemnify, hold harmless and reimburse the District, members of its Governing Board, its officers, employees, and agents from and against any claim which

the Student, the Undersigned, any parent or guardian, relatives or next of kin of the Student, or any other person, firm or corporation may, now or hereafter have or claim to have (known or unknown, seen or unforeseen, directly or indirectly, or within or without the control of those released), for or on account of any losses, damages, personal injuries, pain, and suffering, death, property damage, or contract claims resulting from, or arising out of, during, or in connection with the Student's participation in the above-described activities.

3. The Undersigned hereby agrees not to sue or file a claim with the District for any injury or death to the Student or property sustained in connection with the above-described activities.

4. The Undersigned expressly agrees that this "Release and Wavier of Liability and Indemnity Agreement" is intended to be as broad as is permitted by California law and, if any portion of this agreement is held invalid, it is further agreed that the remaining portions shall continue in full legal force and effect.

5. The Undersigned has carefully read, fully understands its contents, and voluntarily signed this "Release and Wavier of Liability and Indemnity Agreement" and further agrees that no oral representations, statements, or inducements apart from this Agreement have been made.
